22/00697/FUL Application for technical details consent for the erection for 1no. dwelling pursuant to permission in principle 21/00744/PIP at Knotts Farm, Chapel Lane

22/00767/FULHH Two storey side extension at Lowe Fold Farm, Coppice Lane. Cllr Osborne declared a pecuniary interest in this item and took no part in the debate or decision.

Councillors had no objections to these applications.

22/00538/OUTMAJ (Chorley North and Astley borough ward) Outline application for the erection of up to 200 dwellings (including 30% affordable housing) with all matters reserved save for access from Blackburn Brow at Little Knowley Farm, Heapey Road

Resolved: and objection is to be submitted on the grounds that the site is not included for housing in the current Chorley Local Plan, the impact on local services and amenities including school places and increased traffic.
