# 21.36 Apologies for Absence

Apologies were received from Cllr A Crompton.

### 21.37 Declarations of Interests

None declared.

### 21.38 Minutes of the Annual Meeting held on 4 May 2021

Resolved: the Minutes (as circulated) were approved and signed by the Chairman as a correct record.

### 21.39 Public Participation

Residents advised of concerns relating to the planning application for the development on the Black Lion Field. The concerns included the loss of parking spaces on Blackburn Road and increased traffic at the Blackburn Road/Millennium Way junction.

A resident had reported issues with speeding traffic, including refuse wagons and delivery vehicles, on Merlin Close. Chorley Council monitors refuse vehicle speeds and the highest speed recorded on Merlin Close during August was 15mph.

# 21.40 Planning Matters

The following applications were considered:

21/00816/MNMA Minor non-material amendment to planning permission 20/00665/FULHH involving replacement roof over utility room to a dual pitched roof at 16 High Bank

21/00821/FULHH Part two storey/part single storey rear extension (following demolition of existing two storey rear extension and demolition of 3 no. existing out buildings at 4 Brookside Cottages, Coppice Lane

21/00988/FULHH Erection of single storey rear extension (following demolition of conservatory) at 16 Kittiwake Road

21/01050/TCON Notification of proposed tree works to trees within a Conservation Area including the felling of 3no. leylandii and 1 no. dead tree, crown reduce canopy of 1no. holly tree and 1no. silver birch at 1 Warthside, Coppice Lane

Councillors had no objections to these applications.

21/00747/FUL/FULHH Erection of an equine building comprising five stables, tack store and machinery store along with the construction of a new sand paddock with associated hardstanding and lighting columns, following demolition of existing equine stables and storage building at Land adjacent to Heapey Road. A request for the impact of the lighting columns on neighbouring properties to be taken into consideration is to be submitted.

21/00847/FULMJ Outline planning application for residential development specifying access from Blackburn Road (all other matters reserved) at Land next to 190 Blackburn Road

Resolved: an objection is to be submitted on the grounds that the land is not designated for development in the current Chorley Local Plan, the impact on local services in the area and the lack of availability of High School places locally.
