Items suggested included an update on Brinscall Baths (following confirmation of details for publishing from Chorley Council), warnings against cold water swimming, barbecues on the Moors and leaving dogs in cars, parish council grants for local groups and organisations and advertising the hiring of the Village Hall.

25.44 IT Policy

The Annual Governance and Accountability Return (AGAR) for the year ending 31 March 2026 will require all smaller authorities to have an Information Technology policy. A model policy, produced by the Smaller Authorities Proper Practices Panel (SAPPP) was presented for adoption.
